- No. 39 That all notices of motion shall be posted on the notice board of the Institute, seven days prior to any quarterly, annual, or special general meeting at which they are to be submitted for consideration.
- No. 40 That these laws shall not be altered, repealed, or added to except by a majority of two-thirds of the members present at an annual meeting. Notice of such alterations to be given at the previous quarterly meeting.
